What's New in Underwriting

Reminders: Workers' Compensation and Liability Exposure Audit and Property True-Up

With the commencement of our July 1, 2025, renewal, we will now be moving into the Liability and Workers' Compensation Exposure Audits, Property Policy Audit, and the Property True-Up process. Below are items to keep in mind. Thank you in advance for your partnership.

Workers' Compensation and Liability Exposure Audit:

 CRL conducts an audit of all recently expired Workers' Compensation and Liability policies. Please be on the lookout for specific information needed to complete the audits as the timelines and information will vary depending on the type of policy and expiration date.

Property True-Up:

Members are to submit current Schedule of Value (SOV) information to CRL.Underwriting@Countyre.org within 30 days
of the effective date of the Members most recent policy year. The true-up process brings SOVs and property data current
within the July 1, 2025, policy.

Property Audit:

Members are to submit a SOV reflecting all additions and deletions made during the prior policy period, July 1, 2024- July
1, 2025, within 30 days of the expiration of the most recent policy year. The property audit process reconciles SOV
changes made during the prior policy period. This includes additions and deletions.

HSB Jurisdictional Inspections and Engineering Surveys for Property Members

Did You Know?

HSB provides essential services that ensure the safety and compliance of our properties. Here are the key services HSB provides:

Jurisdictional Inspections- The purpose of these visits is to conduct inspections of equipment as required by local jurisdictional authority. They are done to ensure that each member is code compliant based on current state regulations. Marsh provides the Statement of Values to HSB, and they advise what locations have objects that need to be inspected each year based on requirements by each state.

New Code Requirements for Mississippi and Alabama

• Expect increases in object counts due to the new code requirements being enforced. This includes Hot Water Supply Boilers of 5 gallons or greater located in buildings owned or under control of a public entity. These new objects should all have 24-month inspection frequencies.

Property Engineering Surveys- This is necessary for Insurance Marketing. Surveys confirm construction, occupancy, risk protection measures, and management standards. Any special hazards present will be noted (i.e., Fire Risk, Sprinkler System Adequacy, Housekeeping Issues, and Human Element documentation like Hot Work Permits / Impairment tags). The locations are decided between the reinsurance panel, Marsh, and CRL. HSB will schedule in-person engineering visits in coordination with CRL.

HSB Engineering Inspection Report Trends: As of June 2025, HSB has provided a comprehensive set of 89 recommendations aimed at enhancing risk management practices. Among these, 46 were classified as priority recommendations, while 43 were advisory notices. To facilitate your understanding and implementation of these recommendations, we have included a chart outlining the various categories of these suggestions.

Additionally, we have attached valuable resources, including a hot work program template and permit, a fire protection impairment permit, and the NFPA Hot Work reference guide, which we believe will be instrumental in your efforts to ensure safety compliance. We encourage you to take full advantage of these resources as you navigate the path toward improved safety and risk management.
